PHOTOGRAPHY & PHOTO SHOOT POLICY

Photo sessions are allowed by appointment only. A confirmed reservation is required at least 48 hours in advance to ensure that your session will not interfere with a private event, or our regular business operations. All photographers must sign the following agreement and provide proof of insurance before shooting on the property.

Elliston's regular business hours, excluding holidays: Daily 10:00am – 4:00pm

FEES

- Outdoor shooting during business hours – no fee
- Outdoor shooting outside of business hours - \$100 per hour
- Shooting inside the mansion - \$200

User agrees that Elliston may use photographs from the photo session for display, advertising, website, blog and any other means of promotion of Elliston unless written notice to the contrary is received from User. User waives any right to payment, royalties or any other consideration for the use of the photographs, and User waives the right to inspect or approve the finished product for promotional use. Elliston is hereby held harmless and released and forever discharged from all claims, demands, and causes of action which User, their heirs, representatives, executors, administrators, or any other persons acting on User's behalf or on behalf of User's estates have or may have by reason of this authorization.

PHOTO SHOOT POLICIES

Elliston Vineyards requires that all vendors and guests adhere to these policies. A FULLY FILLED OUT, and SIGNED copy of this for must be submitted to Elliston before each photo session. By signing below, you agree to abide by all policies.

- Photography must be conducted without disruption to Elliston operations or limitation to the accessibility of the other guests including doorways, pathways and high traffic areas.
- In order to not interfere with any events, tours, or our regular business operations, please do not arrive before your scheduled appointment time. If you need additional time, please contact our office at least 48 hours prior to your session.
- Upon arrival, please check in with our office.
- The following items are prohibited from Elliston Vineyards: open flames, use of fake petals, confetti, glitter, bird seed, and balloons. No glue or nails are allowed on the walls or structures of the facility. All decorations must be approved by Elliston and removed by the end of the photo session.
- Elliston Vineyards cannot assist with the set up and breakdown of decorations, vendor products and services.
- If you require tables or chairs, please request one prior to the day of set-up from the Elliston staff. Please also come prepared with all necessary supplies and work tools.
- No one should ever stand on our tables or chairs. You are responsible for bringing your own step stools and ladders, Elliston cannot provide them.
- Outside food & alcohol is prohibited.
- You are responsible for any damages to the Elliston property.
- Photographers and videographers must show proof of insurance at least 48 hours before the photo shoot.
- All outdoor music must be non-amplified (no speakers). Elliston reserves the right to control the music volume, or turn music off if necessary.
- Vendors may not store equipment inside the mansion.
